**Status of Field Events**

- **First Semi-Annual Groundwater Sampling Event for 2016**

Groundwater sampling based on the proposed monitoring scope (Gradient memorandum dated March 11, 2016) was conducted at the Site during the month of May except for sampling of the Floridan well CFW-1, which was conducted in June; a report presenting the groundwater sampling results will be submitted by June 30.

- **Confirmation Sediment Sampling**

Weston completed the confirmation sediment sampling event in Springstead and Hogtown Creeks in accordance with the Work Plan, dated October 16, 2015, that was conditionally approved by US EPA in January 2016. The investigation began the week of May 16 and was completed within two weeks.
