The names of all scientists and labs and consultants that were involved in developing the FS and ROD are better obtained from the USEPA who is responsible for both of these documents. ACEPD understands that USEPA Consultant, Black & Veatch, Inc was responsible for assembling the FS and Record of Decision for USEPA. Technical information was provided by Beazer East consultants, GeoTrans, Inc and AMEC, Inc. for the groundwater and soil issues and risk assessment issues. It is my understanding that several labs were used for the analytical data, which includes, Vista Labs in California, Test America Labs and also I believe Columbia Analytical. Other consultants and labs may have been used that we may not be aware of.
