Re: ACEPD Follow-up -- Request for Sampling of Off-site Private Wells Near Cabot/Koppers Site, Gainesville, Florida

Dear Scott:

In an August 23, 2012 meeting in Gainesville between the Alachua County Environmental Protection Department (ACEPD) (Robin Hallbourg and John Mousa), the Alachua County Health Department (ACHD) (Anthony Dennis), Beazer East (Mitch Brourman) and TetraTech (Jim Erickson and Greg Council), and yourself (USEPA), ACEPD (Robin Hallbourg) discussed the multiple offsite private wells known to exist on the properties immediately adjacent to the former Cabot-Koppers Superfund Site and the need to sample and properly abandon these wells. It was discussed at the meeting that there were several partial inventories of these wells compiled by ACEPD, ACHD and TRC in their June 2004 report. ACEPD agreed to work with ACHD to reconcile these lists and data tables in order to provide a more organized inventory to USEPA and Beazer East.

As a follow-up to that meeting, ACEPD has compiled well information from the June 2004 TRC report and March 2009 ACHD well inventory, as well as from field observations by ACEPD staff and has plotted the locations of the wells nearest the site on the attached map, "Cabot Koppers Off-Site Private Wells". An Excel table titled "Inventory of Known Private Potable, Non-Potable, Irrigation and Other Wells Offsite in Vicinity of Cabot Koppers Superfund Site" which is an inventory of currently known wells from the well inventories and field work is also attached (electronically). The number labels on the well locations in the attached map correspond to the well numbering in the attached spreadsheet inventory. ACEPD did not conduct any recent field work to verify the existence of the wells described in the inventories or attempt to locate any additional wells. The table inventory includes wells that are not shown on the attached map.

Many of the wells near the site, shown in the "targeted area" on the map, have not been or can no longer be sampled due to pump condition or site access. There appears to be at least 11 irrigation or former potable supply wells in proximity (located west and north of the Koppers portion of the site) to the site. A number of these wells have been sampled previously and most have not shown detectable levels of site related organic contaminants. Many of these wells have not been

sampled in over five years. Some of these wells are located in areas planned for off-site soil removal. ACEPD recommends that these wells, and any other wells located during the off-site remediation, be sampled and properly plugged and abandoned as part of the off-site soil removal work. Many of these wells are likely completed in the surficial or intermediate aquifer. At least one of the wells (No. 39 on attached inventory and map) located adjacent to western boundary of the former Koppers site at 437 NW 29th Avenue is reported to be completed in the Floridan aquifer system.

ACEPD believes it is imperative that these wells be sampled prior to abandonment, given the documented historical presence of potentially site-related constituents (methlyphenols, naphthalene and BTEX) in at least one offsite private well (the former Geiersbach well off-site to the west, which was previously plugged and abandoned) (No. 61 in inventory and map) and the presence of acenaphthene in sample results reported from on site boundary well FW-22B Zone 2 of 8.7 ug/L on 3/21/2012 and 15 ug/L on 6/18/2012.

Additionally, an irrigation well located close to the northern site boundary at 201 NW 33th Ave. (No. 15 in inventory and map) has confirmed low levels of potentially site related constituents. The table below presents low level PAH data from this northern boundary well for the last three sampling events conducted by ACEPD. This well is completed in the intermediate aquifer (Upper Hawthorn Group) and was reported by TRC to be a total depth of 69.7 feet. Since there is a lack of intermediate aquifer (Hawthorn Group) wells in the northern third of the Koppers portion of the site it is difficult to determine the source of this impact.

To summarize, it is ACEPD's recommendation that if possible all wells within the targeted areas should be sampled for site related constituents to document current water quality and wells no longer in use should be properly plugged and abandoned following water management district protocols. These measures will help insure the protection of groundwater quality in proximity to the site. 
