Mitch-

I am following up on DEP's 7/15/2010 email and our 8/5/2010 phone discussion regarding warning signs required by DEP to alert the public to soil, sediment or surface water contamination associated with hazardous waste sites in Florida. Attached are photos of 2 signs- each are approx 2' X 3', of durable metal construction, and illustrate the generic language used by DEP at our State and Superfund sites. The language and phone numbers on the signs are applicable to the Koppers facility as well. The sign referring to "soils in the creek" pertain to contaminated sediments in Hogtown and Springstead Creeks and these signs have been installed at public access points long the creeks.

I understand that Beazer intends to install warning signs at the Koppers facility and immediately west along the easement. Signs warning of "soil and water" contamination should be posted and include the 3 contact phone numbers (as shown in the attached photo).

As specified in Chapter 62-730.225(4) and referenced by 62-780:

--warning signs shall be at least 2X2 ft, made of durable weather resistant material, with lettering in a color that highly contrasts with the background. All lettering must be at least 1" high.

--warning signs shall be unobstructed and mounted in such a maner that the center of the sign is approx 56" above ground surface and capable of being seen from at least 75 ft away from all access locations.

--warning signs shall warn of danger, prohibit unauthorized entry, convey other information appropriate to site conditions, and include a telephone number for more information.

DEP appreciates your attention and prompt responsiveness to these requirements. Please let me know what Beazer's schedule is for the sign installation. We anticipate that sign procurement and installation can be accomplished within the next 30-45 days. Please let me know if you have any questions about the signs or their placement/locations.
