Please find attached, DEP review comments of the above referenced document for the Cabot Carbon/Koppers site. Overall, the revised work plan has addressed previous DEP review comments.

In particular, DEP cautions against inappropriate compositing of soils from different borings. We acknowledge that in the saturated zone, compositing over a limited vertical interval within the same boring may make sense based on field observations, to support evaluation of potential pine tar sources and identify zones for remediation. We request that the work plan clarify the basis for selection of those saturated zones for vertical compositing and what maximum vertical interval is being considered for compositing in the saturated zone.

We look forward to completion of the field work and receipt of the data, and recommendations for permanent monitoring wells and remedial treatability testing.
