**Subject:** RE: Gainesville Revised Off-Site Sampling Plans

Scott- I thought I had sent this email to you previously. I apologize for the oversight.

DEP has reviewed the revised April 26, 2010 work plans for offsite soil sampling at the Cabot/Carbon Koppers site.

### Western Grid Sampling Work Plan:

We continue to recommend that sampling include those additional offsite soil samples immediately west of the Koppers property boundary, as identified in DEP's review comments. While we understand that this sampling could also occur during design, our intent is to focus vertical delineation of dioxin contamination to 7 ppt as expeditiously as possible and to better ascertain the magnitude of contamination in the offsite areas closer to the highest dioxin concentrations previously observed in the easement. The proposed locations for 6"-2' vertical delineation in the work plan are further west and generally in areas where dioxin concentrations < 70 ppt- these sample results will likely not be representative of the magnitude and/or vertical extent in areas where confirmed dioxin contamination over the 0-6" interval is much more significant. Sampling at this time could also serve to streamline the removal design process, with fewer sampling events required during the design phase.

We accept the remainder of AMEC's West Grid proposal with the understanding that additional sampling will be undertaken as necessary in the future to complete delineation of offsite soil contamination to SCTLs and/or confirmed background levels. We strongly encourage EPA and Beazer to move as expeditiously as possible to complete the necessary offsite delineation and resulting soil remedy.

### South, east, Northeast and Non-residential Background sampling Work Plan:

We accept the revised work plan scope for the current phase of sampling with the understanding that it may not be adequate to support final conclusions regarding the presence or extent of offsite contamination, as discussed in DEP's previous comments.

We appreciate the continued efforts to address site related contamination and look forward to implementation of the final selected remedy.
