DEP has reviewed the Koppers work plans for the sentinel wells. It was unclear in the proposal whether or not the Westbay system was to be used in the multi-zone screen construction proposed for the offsite wells. While these wells are being installed in an area that is likely unaffected by Koppers facility contamination, it is critical that well construction ensure that representative samples are obtained from each of the screen intervals.

Therefore, Westbay construction or similar should be used to provide that assurance.
