EPA approves the Upper Floridan Aquifer IRM workplan and the responses with the exception of the response to EPA comment #1 related to test methods and practical quantification limits (PQL). We want to research Beazer's response and desire to discuss this issue further with Beazer/GeoTrans and other stakeholders. This conditional approval should allow Beazer to continue construction of the Floridan IRM without delay while EPA and other stakeholders examine the test method/PQL response more closely. We would suggest that the May 18th monthly Koppers Site status call would be a good place to continue this discussion. Thank you for all of your efforts at the Koppers Site.
