Hi Jeff - A couple of comments / questions:

## **Fact Sheet**

Page 3 of 16, third paragraph – last sentence is repeated twice. **Ok, updated**Page 4 of 16, fourth paragraph – indicates that "air monitoring will be conducted"; you may want to specify what type of air monitoring, particulates? **Ok, updated**Page 8 of 16 – suggest showing location of SWU-2 in Figure 1 **ok, yes this is being updated.**Page 14 of 16 – paragraph (f) Irrigation and on-site water reuse; are they currently doing this? **No not at this time. They will need to submit a permit revision with details.** 

## **Permit**

Page 6, copper – "The compliance value shall not exceed <u>0.00</u>", is this correct? Yes, this calculates a comparison between the lab analysis value reported and the permit limit calculated based on hardness. So if the result is less that the limit, it is in compliance. This is a data processing procedure.

Page 7, chromium — "The compliance value shall not exceed <u>0.00</u>", is this correct? Yes, this calculates a comparison between the lab analysis value reported and the permit limit calculated based on hardness. So if the result is less that the limit, it is in compliance. This is a data processing procedure.

### **Administrative Order**

Page 7, end of first paragraph — "The concentrations of total recoverable copper.....not exceeded Class III water quality standards for fresh water (Rule 62-302 FAC)". My understanding is that this is after the remedial actions are completed, there are no limits in the interim; correct? Also, should "exceeded" be "exceed"? Yes, that sentence can be revised or removed since in the interim, they are sampling and reporting only. In the future, once final remedial actions have taken place, then they must meet 62-302 standards.
