Hi Scott,

GeoTrans is presently overseeing the demolition work Beazer's contractors (Chemtron and B&L) are doing at the Gainesville Site. The demolition work is part of the EPA-approved Short-Term IM Plan from June 2010 and was recently permitted by the City. The work started Monday December 6. It will continue next week, then off for two weeks, and will finish in January. Plenty of folks from the City, County, and State have been by during the work and surely will for the remainder of it (which we welcome).

FYI: We are conducting dust and noise monitoring during these activities. We think this will give us good documentation in case members of the community raise concerns. We are following the attached monitoring plan. So far, noise and dust levels have been very low.
