> Mr. Pearce:

> The current consent order is in place through the time before the permit is issued. Then the permit and Administrative Order (AO) both will be in effect. The way these documents work is that the AO describes and establishes interim requirements for total recoverable copper, total recoverable arsenic, total recoverable iron, trivalent chromium, total polycyclic aromatic hydrocarbons (PAH), Pentachlorophenol (PCP) and a schedule for compliance. The AO runs concurrently with the Permit.

>

> Since dioxin/furans is not in the AO, the permit describes the sampling requirement on a quarterly basis (page 5 of the permit). So for a qualifying storm water discharge from the site, the collected sample must be analyzed for dioxin/furans. Hope this helps to clarify the documents. I will give you a call either today or on Friday to discuss. Thank you for your comments,
