Scott, attached is Beazer response to the GRU comments on the FW-32BE workplan. We do not agree with a number of the proposed changes to the well design, as detailed in this letter; however, we will incorporate some of the suggested changes to the aquifer testing program. I'm assuming that formal changes to the workplan are not required to move forward with the well installation, but will await your approval.

We are trying to mobilize to drill this well by the end of Nov or early Dec, and have Boart Longyear tentatively scheduled to drill the well.
