Good afternoon, Steve-

I am following up on a voice mail that I just left you regarding the warning signs that DEP and Alachua County are trying to install along Springstead Creek at NW13th and NW 6th Streets.

Warning signs are required in accordance with Chapter 62-780 and 62-730.225(4), Florida Administrative Code, to alert the public to soil, sediment or surface water contamination associated with hazardous waste sites in Florida; in this case, contaminated soil or sediment in Springstead and Hogtown creeks associated with the Cabot Carbon/Koppers Superfund site. DEP has completed installation of the other warning signs along these creeks. Only those to be located in the DOT ROW remain to be installed. DEP will coordinate with the EPA and the responsible parties (Beazer East and Cabot Carbon) to ensure that the signs are subsequently maintained. Examples of signage posted to date are attached.

I understand from your email below that DOT may require an MOU for access for sign installation. Can you let me know of your availability next week- along with Ms. Jocelyn Croci - to discuss what the next step is in obtaining DOT access for the sign installations?

I am out this Friday but look forward to speaking with you next week. Thank you.

Kelsey,

I just spoke with John Mousa (Alachua County DEP) about the subject signs. He recommended I get in touch with you.

I have received confirmation from our legal staff that we can allow this type of sign on our right of way. However, before anything is installed, we would like to have a signed Memorandum of Understanding (MOU) between our agencies providing some background on the need for the signs, who will install them, and who will be responsible for any subsequent repair or replacement work.

Our staff counsel that drafted this MOU is Ms. Jocelyn Croci. She has asked me to obtain a point of contact to send this draft document to. Would you be that contact? If not, could you let me know who the appropriate contact would be and how I could contact them?
